

Notice for authors taking advantage of Open Access agreement with Wiley

How your submitted article is affected if your journal is transferred between publishers

September 2023 Wiley Publishing Japan Toward 2024, some journals will be transferred between Wiley and other publishers. This document clarifies how journal transfers will affect authors who are going to publish articles in open access (OA) through your institution's transformational (ie Read & Publish) agreement with Wiley.

If your journal is transferred from Wiley to another publisher

- Your article is eligible for the transformational agreement with Wiley only if (1) your OA
 request is approved by your institution and (2) your article's publisher version is
 published by Wiley (ie published as Early View)
- Even if your OA request has been approved, your article will not be eligible for the transformational agreement with Wiley if your article's publisher version is published not by Wiley but by another publisher after journal transfer. In that case, the approval of your OA request will be cancelled
- In the above case, if you submitted your article to a Full Gold OA journal (ie journal that publishes all articles in OA), you may have to pay APC (article publication charge) to a new publisher. If you submitted your article to a Hybrid Journal (ie subscription-based journal that offers an OA option), however, you can choose to make your article non-OA to avoid APC payment. Please be careful when you submit an article to a journal that will be transferred

- Transfer dates are determined by individual journals, and therefore a journal may be transferred in the middle of a year instead of the 1st of January. The transfer date is usually displayed on the journal's homepage (see below), but if you have any questions, please contact the journal's editorial office

If your journal is transferred from another publisher to Wiley

• The eligibility of your article for the transformational agreement with Wiley depends on the type of journals:

Full Gold OA Journal ... When a journal is transferred from another publisher to Wiley, your article will be eligible for the transformational agreement with Wiley **if your manuscript is submitted to Wiley** when the agreement is in effect. On the other hand, if an article has been submitted to a previous publisher, it is not eligible for the transformational agreement with Wiley even after the journal transfer.

Hybrid Journal ... regardless of which publisher your articles has been submitted to, **if the article is accepted for publication after the journal is transferred to Wiley**, it is eligible for the transformational agreement with Wiley. If an article has been accepted by a previous publisher, it is no longer eligible for the transformational agreement with Wiley.
